

**Baaqa Wadajir ah ee Wadatashigii Saxiixayaasha Khariidada
Dhameystirka Xilliga ku meel gaarka Somalia
Nairobi, 22 June 2012**

Saxiixayaasha khariidada dhameystirka kumeelgaarka Soomaaliya, waxay kulan ku yeeshen Nairobi, Kenya laga bilaabo 20 ilaa iyo 22 June, 2012 si ay wadaxaajood dheeraad ah uga sameeyaan higelinta khariidada dhameystirka kumeelgaarka Soomaaliya. So gaar ah waxay diiradda u saareen sidii hoey loogu dhigi laa hifelinta waxyaabihii ay ku heshiiyeen shirkii Addis Ababa, Thiopia, ee 21dii ilaa 23dii May kaasoo looga gol lahaa dedejinta tubta nabadda.

Shirka waxaa sahashay Quruumaha midoobay, gaar ahaan u qaybsanaha arrimaha Somalia ee Xoghayaha Qaramada Midoobay, Danjire Augustine P. Mahiga.

Shirka Nairobi waxaa ka soo qaybgala Madaxda Saxiixayaasha Khariidada (Roadmap Signatories), sida Mudane Sheikh Sharif Sheikh Axmed, Madaxweynaha Dowladda Federaalka KMG ah (DFKMG) ee Somalia; Mudane Sharif Xassan Sheikh Adan, Af-hayeenka Baarlammanka DFKMG ah ee Somalia, mudane Cabdiweli Maxamed Cali, Rai'sul Wasaaraha Dowladda Federaalka Soomaaliya; Mudane Cabdiraxman Maxamed Maxamud (Farole), Madaxweynaha Dowladda Puntland; Mudane Maxamed Axmed Caalin, Madaxweynaha Galmudug; iyo Sheikh Maxamed Maxamud Yusuf (Aw'Libaax), Wakiilka Ururka Ahlu Sunna Wal Jama'a.

1. Protokoolada Dhameystirka Kumeelgaarka:

- a) Saxiixayaasha Khariidada Dhameystirka Xilliga KMG ah markay ka doodeen dib-u-eegidna ku sameeyeen dhameystirka KMG ah oo ay kasoo shaqeeyeen Guddiga Farsmo ee Dib-u-eegidda Dastuurka ee lagu soo dhisay heshiiskii Addis Ababa ee qabsiimay May 21-23, 2012.

Sidaa darted Saxiixayaashu waxay isku raaceen saxiixeena qodobada soo socda:

Sidoo kale, Madaxweynaha DFKMG ah wuxuu saxiixay Xeer ay goobjoog ka yihiin dhammaan Saxiixayaasha, Xeerkaasoo ogolaanaya Protokoolada kor ku xusan oo dhisaya nidaam sharci ah oo lagu dhamaystiro geedisocodka Dastuurka Somalia iyadoo loo marayo ansixin ku meel gaar ah (provisional adoption) ee Dastuurka Somalia oo ay u codeenayaan Ergada Ansixinta Dastuurka.

2. Qabyo-qoraalka Dastuurka KMG ah

Saxiixayaasha ayaa si wadajir ah u saxiixay nuqulkii ugu dambeeyey ee Qabyo-Qoraalka Dastuurka KMG ah oo ay soo dhamaystireen Guddiga Farsamo ee Dib-u-Eegida Dastuurka (Technical Revision Committee) ee Addis Ababa. Kani hadda, waxaa weeye, Dastuur KMG ah ee Somalia. Guddiga kor ku xusan magaciisa waxaa loo badalay Guddiga Farsamo ee Fududeynta Howlaha (Technical Facilitation Committee), waxaana Gudoominaya Wasiirka Arrimaha Dastuurka iyo Dib-u-heshiisiinta ee DFKMG ah.

Inta aan Qabyo-qoraalka Dastuurka KMG ah la hordhigin Ergada Ansixinta Dastuurka, Hey'adda IFCC ayaa qaban doonta wacyi-gelin si loo kordhiyo aqoonta Dadweynaha ee arrimaha Dastuurka KMG ah, wacyigalin taasoo qaadan doonta muddo dhan 4-berri. IFCC ayaa Qabyo-qoraalka Dastuurka KMG ah dib ugu celin doonto Guddiga Farsamo ee Fududeynta Howlaha (Technical Facilitation Committee), Guddigaasoo ah Guddiga leh mas'uuliyadda u bandhigidda Ergada Ansixinta ee Qabyo-qoraalka Dastuurka KMG ah.

3. Ergada Ansixinta Dastuurka (National Constituent Assembly)

Shirweynaha Ergada Ansixinta Dastuurka ayaa furmi doona 12 July 2012 wuxuuna soo xirmi doonaa 20 July 2012. Ergada Ansixinta Dastuurka waxaa la kala dirayaa markii ay soo gabogabeeyaan codeynta ansixinta KMG ah ee Qabyo-qoraalka Dastuurka, ka hor inta aan loogu soo bandhigin Dadweynaha Soomaaliyeed cod-bixin toos ah.

4. Dhisida Guddiyada Dhamaystirka Xilliga KMG ah
